

HOTĂRÂREA NR. 83

privind anularea obligațiilor fiscale datorate de debitori, persoane juridice, radiati din Registrul Comerțului și scăderea societăților comerciale radiate din evidența fiscală

Consiliul Local al Municipiului Tulcea, întrunit în ședința ordinară din data de 27 aprilie 2016, legal constituită;

Examinând proiectul de hotărâre privind anularea obligațiilor fiscale datorate de debitori, persoane juridice, radiati din Registrul Comerțului și scăderea societăților comerciale radiate din evidența fiscală, proiect din inițiativa Primarului;

Ținând seama de prevederile art. 266 din Legea nr. 207/2015 privind Codul de procedură fiscală, cu modificările și completările ulterioare;

În temeiul art. 36 alin. (2) lit. b) și alin. (4) lit. c), art. 45 alin. (1), (2) și (6), art. 49 alin. (1) și (2) și art. 115 alin. (1) lit. b) din Legea administrației publice locale nr. 215/2001, republicată, cu modificările și completările ulterioare

HOTĂRĂȘTE:

Art. 1. Se anulează obligațiile fiscale datorate de debitori, persoane juridice, radiati din Registrul Comerțului pentru care nu s-a atras răspunderea altor persoane, prevăzute în anexa nr. 1 care face parte integrantă din prezenta hotărâre.

Art. 2. Se aprobă scăderea din evidența fiscală a societăților comerciale radiate din Registrul Comerțului, prevăzute în anexa nr. 2 care face parte integrantă din prezenta hotărâre.

Art. 3. Cu ducerea la îndeplinire a prezentei hotărâri se împuternicesc Primarul Municipiului Tulcea și Serviciul Impozite și Taxe, organul fiscal din cadrul Direcției Economice.

Art. 4. Secretarul Municipiului Tulcea va asigura comunicarea prezentei Hotărâri autorităților și persoanelor interesate pentru ducerea la îndeplinire a prevederilor sale.
